# Training for personnel of water bottling plant

SABA--Personnel of drinking water bottling plant Saba Splash last week completed a three-day training on important aspects in the production, bottling and distribution of drinking water. Water Opleidingen from the Netherlands did the training. Vitens Evides International (VEI) assisted with the coordination of the training.

Plant manager Oscar L. van der Kaap and Saba Splash employees Justin W. P. Linzey and Shannon Levenstone participated in the training to refresh their knowledge, but also to learn new techniques which ensure the quality of the water during the sampling and bottling process. Other aspects were also part of the training, such as employee safety and hygienic working.

Overall, trainers Fred Rihkers and David den Dulk were very pleased with the Saba Splash employees and the facility, which was constructed with funding by the Ministry of Infrastructure and Water Management. The facility opened early November 2021.

At the new plant, three- and five-gallon water bottles are filled, using a state-of-the-art system that produces healthy, safe and affordable drinking water, providing a basic need for the Saba people.

"We are fortunate to have such a professional bottling plant here on Saba. Now we have a properly trained and dynamic team that will ensure that the quality of Saba Splash is well maintained," said Commissioner Bruce Zagers.

He congratulated the team upon the completion of the training and thanked them for their efforts in building the Saba Splash brand.

Day one of the training consisted of, among other things, training on the job that focused on how the treatment of drinking water is structured, how the process line works within the bottling plant for making and supplying drinking water, how to maintain a safe and hygienic process, how to ensure that the water meets the requirements of the Drinking Water Law BES, how to ensure business continuity, and how the quality control system is set up and used in practice to meet the legal quality standards.

The second day of training focused on how to make drinking water, the extraction, seawater and spring purification, Reversed Osmosis (RO) installation, the basic distribution overview that included the construction and design, pipes and materials, and the water quality in the grid.

This day also included a session on working safely, and an on-the-job training that focused on the storage of materials and the water supply to customers.

Working safely and the chemical and microbiological aspects of the drinking-water process were the focal points of the third and last day of this successful training. At the end of the training, the participants received a certificate.

# Van Huffelen tours museum, meets Heritage Commission

ST. EUSTATIUS--State Secretary for Kingdom Relations and Digitisation Alexandra van Huffelen on Monday visited St. Eustatius Historical Foundation Museum. She received a complete tour and was provided with insightful and thought-provoking historical facts. Van Huffelen showed great interest in cultural heritage and in the Golden Rock archaeological site in particular.

On January 27, St. Eustatius Heritage Research Commission (SHRC) presented its findings and recommendations about the Gold Rock site to the Public Entity St. Eustatius.

State Secretary Van Huffelen met with SHRC representatives Ishmael Berkel and Joshua Paul Spanner. She spoke at length with the state secretary and addressed issues related to cultural heritage and slavery in particular.

Spanner stated that an apology from the Netherlands to the Dutch Caribbean islands for its slavery past would be a good start.

Berkel focused on cultural heritage and on Statia adopting the recommendations in SRHC's report, in particular the re-interment of the skeletal remains of enslaved people which were removed and to place a monument at the location for Emancipation Day, on July 1.

Government Commissioner Alida Francis stated that earlier on Monday she had sent a letter to Minister of Education, Culture, and Science OCW Robbert Dijkgraaf with a copy to Minister of Home Affairs and Kingdom Relations BZK Hanke Bruins Slot in which it was stated that the Public Entity St. Eustatius is reaching out to the OCW Ministry for support in taking a closer look into all aspects related to cultural heritage and to come together with stakeholder cultural organisations and the community of Statia.

In the letter, which was also presented to State Secretary Van Huffelen, the ministry was asked for technical support in the form of appointing and financing a cultural heritage expert, who is to work with the Culture Department, cultural heritage institutions and the community in putting a plan in place for management of all cultural heritage matters in Statia, and for the implementation of the recommendations mentioned in the SHRC report.

The island government also wants to make use on a regular basis of young, professional civil servants ("Rijkstrainees") who have completed their education at the university level.

The public entity is hopeful that an arrangement can be set up with the OCW Ministry to bring some of these young professionals to Statia.

"For us it is very important that in every step of the way we include the wider community of St. Eustatius. The community needs to be a part of the whole plan of approach. The island's culture and heritage are under threat, many people have stated, with all the development taking place and the development that is scheduled to take place. The island needs to find the right balance between development and preserving its culture and heritage," Commissioner Francis said.
